



TERMS OF PARTICIPATION FOR THE SPLASH CONTEST

1. General terms of participation

 The organizer of the SPLASH Contest (hereinafter: the "Contest") is K2 Sports Europe GmbH,

 Participation is free of charge.
 The Contest begins on December 1, 2019, at 8 am (CET) and ends on April 30, 2020,
 at 11:59 pm (CET) (hereinafter: the "Promotion Period").

2. Eligibility/participation

- All natural persons residing in Europe are eligible to participate.

 Participants must be at least 3 (three) years of age. Minors (under 18) must have written permission from a legal representative (parent or guardian) in order to participate in the Contest as well as for all legal declarations
- representative (parent or guardian) in order to participate in the Contest as well as for all legal declarations associated with their participation.

 Each participant may submit only one entry in his or her own name. Multiple entries are not permitted. In order to participate in the Contest, the participant (or parent / guardian) must complete and sign the form found inside the packaging of the K2 Raider Splash or K2 Marlee Splash Skates, or downloaded from the page www.k2skates.com/splash-contest-eu, and return it either to K2 Sports Europe GmbH, Seeshaupter Str. 62, D-82377 Penzberg or to splash@k2sports.de during the Promotion Period.
- 5. The time of entry is determined by the time when the form is recorded as received. Entries submitted outside the Promotion Period will not be considered. The Organizer is not responsible for any delays in returning the form.

 6. By returning the abovementioned form, the Participant explicitly acknowledges these terms of participation.

3. Exclusion from the Contest
